CONCEPT NOTE

Background

Since its adoption by the African Union (AU) in 2003, the Comprehensive Africa Agriculture Development Programme (CAADP) has been Africa's primary policy framework for agricultural transformation, wealth creation, food security, economic growth, and prosperity. It guides the African Union Commission (AUC), the African Union Development Agency-New Partnership for Africa's Development (AUDA-NEPAD), Regional Economic Communities (RECs), and Member States in driving agricultural transformation toward a self-reliant and productive Africa.

The Kampala CAADP Declaration and the associated CAADP Strategy and Action Plan (2026-2035) adopted in January 2025, will build on the successes and deepen the progress achieved after two decades of CAADP implementation, during which Africa significantly improved in economic and agricultural growth, poverty reduction, nutrition outcomes, and agricultural trade expansion. The next 10-year cycle of CAADP implementation must further deepen its focus to incorporate lessons while responding to emerging issues to accelerate sustainable food systems transformation in Africa within a context of climate change and multifaceted stressors and shocks.

The longevity and continued success of CAADP can be attributed to its credibility as a shared framework designed to guide Member States toward agricultural transformation and economic growth. Driven by the CAADP principles and values, with emphasis on African ownership and mutual accountability, alongside review and benchmarking, data and analytics have been central to CAADP's evidence-based planning and implementation approach. As Africa prepares for the implementation phase of the Kampala Declaration, which comes into force on January 1, 2026, evidence and robust data analysis will continue to remain indispensable to the successful implementation on the ground. This is the rationale behind AKADEMIYA2063's Kampala CAADP Series.

The purpose of AKADEMIYA2063's Kampala CAADP Series is to provide a policy deployment package to support the domestication and implementation of the Kampala CAADP Declaration. With workstreams covering diagnostics, policy briefs, power briefs, as well as webinars, the series aims to serve as a reference toolbox for policy analysts and planners across the AU Member States as they prepare their programs in response to the Kampala Declaration. AKADEMIYA2063's offering will center on evidence-based research, with lessons and insights packaged into comprehensive yet accessible knowledge products, policy program diagnostics, and policy dialogue sessions with a broad range of stakeholders to guide programmatic interventions supporting the implementation of the Kampala CAADP Declaration.

Session II Objectives

Session II of the *Kampala CAADP Series* webinar will examine the role of knowledge systems in the conception and deployment of policy processes. The effectiveness of policy interventions is largely dependent on the ability to leverage institutional knowledge for a sound understanding of historical context, rationale behind past decisions, and implementation outcomes. Knowledge systems components, comprising knowledge capital, processes, and technology, combined with strategy, play a crucial role in policy planning, implementation, and assessment toward sustainable outcomes.

As such, the session, themed "Connecting Knowledge Systems and Policy Processes: Lessons for Phase Three of CAADP Implementation," will discuss the role of data, analytics, and expertise with reference to the previous 20 years of CAADP, honing in on lessons and best practices for the implementation and domestication of the Kampala CAADP Agenda. The event will discuss the findings of three Kampala Policy Briefs tackling the following thematic areas:

- Africa at a Turning Point: The Significance of the Kampala CAADP Declaration
- Lessons Learned from Implementing the CAADP Biennial Review Process Under the Malabo Declaration
- Leveraging Data and Analytics for Accelerated Agrifood Systems Transformation The Role of Data Platforms and Localized Expertise in Africa

The session will convene a broad range of stakeholders, including policymakers, non-state actors, and other practitioners at continental, regional, and national levels, as well as development partners, to:

- Demonstrate the Central Relevance of Data in CAADP Implementation: Enhance understanding of the CAADP historical context and the role played by data and analytics in informing decisionmaking processes. The speakers will discuss a functional model for facilitating stakeholder dialogue and multisectoral collaboration around data toward accelerating the implementation of the Kampala CAADP Agenda.
- 2. Highlight Innovations CAADP in the Kampala CAADP Declaration: Highlight the significance and innovations of the Kampala CAADP Declaration in shaping Africa's agricultural transformation agenda and clarify what sets Kampala CAADP apart from previous CAADP cycles.
- **3.** Review Progress from the Malabo CAADP Biennial Review (BR): Discuss key insights, progress, and challenges from the CAADP BR process to guide the design, refinement, and implementation of the next BRs under the Kampala Declaration.
- **4. Discuss Lessons to Advance Policy Action:** Review best practices and lessons, with policy recommendations to facilitate decision-making to drive impactful and inclusive food systems transformation across the continent. Provide a platform for African governments, non-state actors, practitioners, and development partners to exchange on the strategic framework to facilitate implementation and domestication toward sustainable policy outcomes.
