Introduction

The Government of Uganda, under the leadership of the Ministry of Agriculture, Animal Industry and Fisheries (MAAIF) in collaboration with Development Partners, conducted the 3rd Joint Agricultural Sector Annual Review (JASAR) workshop on 7th and 8th November 2013 at the Commonwealth Resort, Munyonyo.

The theme of the JASAR was “**Agriculture for Food and Income Security**”, which is also the overriding theme of the DSIP. The two-day program is shown in **Annex 1**.

Prior to the workshop, four field trips were arranged during October 28-31 2013. The districts visited and activities done are briefly shown in **Annex 2**. The four field reports are available on the Ministry’s website (www.agriculture.go.ug).

The list of papers presented during the workshop is attached as **Annex 3**.

On day two, five groups were formed to discuss and present recommendations based on the following questions:

- How do we further strengthen the integration and intervention of MAAIF and Agencies in the District Local Governments?
- MAAIF adopted a Commodity Approach to planning and investment in the sector. What needs to be done to strengthen implementation?
- Research – Extension interface. How can this be strengthened / scaled up to increase technology adoption and productivity?
- Mindset / Attitude. What needs to be done to re-orient community’s perception to agriculture? (Farming seen as punishment to farming as a business).
- Policies, regulations and guidelines in the agricultural sector. Issues and the way forward?

The workshop was officially opened by the Rt. Honorable Prime Minister of Uganda. He condemned the common stance in schools and prisons, of using agricultural work as acts of “punishment”, as partly responsible for the negative attitude that many people have towards agriculture. We need to start addressing agriculture from a different perspective.

After a two days discussion of the presentations, the review was officially closed by the Hon. Minister MAAIF, Tress Bucyanayandi on 8th November 2013.

- The Minister noted that MAAIF should draw up work plans for each sub-sector, in an output oriented format to implement recommendations of the 3rd JASAR, so as to address identified issues before the next performance review.
- MAAIF, other Ministries together with Development Partners, the Civil Society, Academia, the entire Private Sector and farmers should all be part and partial of planning, implementation, monitoring and evaluation of the entire agricultural sector value chain.
- MAAIF activities are targeted to provide household-level technology application including fertilizers, irrigation and mechanisation with a view to raise income to UGX 20 million per year.

- Government will promote Agricultural financing at reduced interest rates from production to value addition. Value addition for some specific commodities like coffee, textiles and processing of some fertilizers will be undertaken at East African Level.
- The government will also address mindset change through the National Farmers' Leadership Centre (NFLC) at Kampiringisa, in Mpigi District, funded by Korea International Cooperation Agency (KOICA). Agricultural colleges will continue to champion research and extension.

2 The Objectives of the 3rd JASAR

- Assess performance of the agricultural sector during the Financial Year 2012/2013;
- Assess progress on implementation of sector priorities for FY 2012/2013 - achievements and challenges;
- Assess public budget allocation and expenditures;
- Assess implementation status of JASAR 2012 recommendations;
- Provide recommendations for increased effectiveness and efficiency in sector performance.

3 Joint Sector Review Issues Emerging from the Presentations

Technical officials, mainly sub-sector heads in the MAAIF and other sister institutions, presented reports focusing on core sector performance for the Financial Year 2012/2013. The presentations included the sub-sectors of; Crops, Animals, Fisheries, NARO and NAADS (in that order). The presentations focused on sector targets, achievements / outputs and challenges faced.

Other presentations made during the review included a statement by Agriculture Development Partners, Private Sector Foundation, Uganda National Farmers Federation (UNFFE), and a presentation on the status of implementation of the 2012 JASAR recommendations.
